Motion by Reister and seconded by Cameron to approve a 4% increase on hourly wages across the board in wages, with no change in other benefits. Wages will be as follows Carol Berndt will go from \$8.74 to \$9.09, Allen Kocmich will go from \$10.66 to \$11.09, Ryan Rucktaschel will go from \$8.00 to \$8.32, Roland Like will go from \$11.18 to \$11.63, Don Mudder will go from \$9.88 to \$10.28, and Jo Wormsbecher will go from \$7.28 to \$7.57. No change in Mayor and Council wages. They will stay at \$1,200.00 (Mayor) and \$600.00 (Council) per year. All voted "aye". Motion carried
