Motion by Kuhlman and seconded by Reister to approve the addition of the \$1,655.14 payment to the general fund claims for the month. All voted "aye". Motion carried.

Motion by Reister and seconded by Tolsma to declare The Avon Clarion, a newspaper published and printed in Avon, SD, to be the official newspaper for the coming year. All voted "aye". Motion carried.

Motion by Reister and seconded by Kuhlman to declare the Community Bank of Avon, SD the official depository for the coming year. All voted "aye". Motion carried.

Motion by Kuhlman and seconded by Mensch to declare Thomas Alberts the City Attorney for the coming year. All voted "aye". Motion carried. Bob Macy arrived at 7:17 p.m.

Motion by Tolsma and seconded by Tjeerdsma to set the Annual Election for April 8<sup>th</sup> 2003. Polls to be open from 7:00 am to 7:00 pm central daylight savings time: Polling Place: Avon Community Fire Hall. Election Officials Myra Klock, Reta Ridgway, and Shirley Yonkers. All voted "aye". Motion carried.

Matt Kerr District III and Jerry Yule arrived at 7:28 p.m.

The Pool Fund Raising was discussed the amount shown on the Clarion thermometer includes the monies promised from the state grant, city monies, bank match and the Chamber money. Actual money in the account as of Dec. 31, 2002 was \$23,955.96. Upcoming events were discussed and dates were given.

Motion by Kuhlman seconded by Reister to have Mayor Bechtold go ahead and add the lawn mower and tractor to the insurance policy. All voted "aye". Motion carried.

Mayor Bechtold opened up the Public Hearing as advertised in the paper: CDBG HEARING MINUTES

LOCATION: Avon City Office DATE: January 6, 2003 TIME: 7:30 p.m.

Mayor Bechtold opened the Community Development Block Grant (CDBG) public hearing. The City of Avon is proposing to submit a CDBG application for improvements at the swimming pool.

It was explained that the State of South Dakota has administered the federally funded Community Development Block Grant Small Cities program since 1982. Only cities and counties with populations of less than 50,000 can participate in the Small Cities Program.

Funds are distributed from three separate programs that address three distinct areas of need:

- 1. Imminent Threat Program
- 2. Special Projects

## 3. Community Projects

Funding requirements and the competitive nature of the programs were then discussed. It was emphasized that only those projects demonstrating the most serious need will be funded.

The proposed project was then explained and discussed with those in attendance. The proposed project involves removal and replacement of the concrete deck, and installation of equipment that will help the pool operate more efficiently. The City of Avon intends to request \$93,000 from the CDBG program for construction and grant administration. One resident did not speak against the project, but questioned the council as to future costs associated with the pool. Specific points of concern included: operation and maintenance costs, liability issues, and the burden on local taxpayers. The mayor and council appropriately addressed the residents concerns.

There being no further comments, Mayor Bechtold declared this portion of the hearing closed at 7:50p.m.

## COMMUNITY DEVELOPMENT AND HOUSING NEEDS

Mayor Bechtold called for comments, noting that the purpose of this section of the hearing is to identify community development and housing needs for Avon and identify activities that could be undertaken to meet these needs. The City Council will then prioritize those needs that have been identified.

Various suggestions were made to/by the Council. Attached is a prioritized listing of the identified needs and potential activities proposed to address these needs. Discussion also centered on what financing is available to undertake some of the proposed projects. It was pointed out that the City could not immediately meet many of the needs because the ability to pay for these projects is not within the City's capacity.

The City of Avon held the required Community Development and Housing Needs Public Hearing on January 6, 2003. Hearing participants were asked to identify the major community development and housing needs of the City and discuss activities that could be undertaken to meet these needs. Following is a prioritized listing of the needs identified.

Provide a primary means of recreation for the youth in the City of Avon and the surrounding community. The swimming pool is an essential asset that provides an alternative to crime,

vandalism, drugs, and alcohol which are activities that children may get involved in if there were no other means of entertainment.

Capitalize on development opportunities on Main Street and Highway 50.

Continue support of economic development. Finance activities of local development corporation to enable businesses utilize grants (CDBG) and loans (REDI).

Housing for low and moderate-income persons/families, the elderly and an assisted living facility. Sources of financing may include Rural Development and South Dakota Housing HOME funding. Other innovative programs such as the Governor's House should be encouraged for low-income families.

Continue water and waste water development activities. When appropriate, the City will apply for loans and grants along with additional user fees.

Actively pursue funding assistance for larger road and ancillary infrastructure repairs and modifications.

Bob Macy, Jack Brodeen and Matt Kerr left at 8:25 p.m.

The discussion of the drainage project was then held sheets showing the size of pipe and the length of each needed was then given to each Councilman. It was decided to bid the project as phases. With the city buying the supplies needed for the project and asking for bids on the digging part of the project only. Jerry Yule gave the council some suggestions that he would use on the project.

Motion by Reister and seconded by Tolsma to have the bid prepared and published to be opened at the February Council meeting on the 3<sup>rd</sup>. All voted "aye". Motion carried.

Jerry Yule left at 8:55 p.m.

At this time sealed bids were opened. Motion by Reister and seconded by Mensch to accept the bid of \$1,025.00 for the payloader from Bob Ridgway. All voted "aye". Motion carried.

Motion by Tjeerdsma and seconded by Kuhlman to reject the \$100.00 bid received on the Library Building. No other action taken at this time. All voted "aye". Motion carried.
