## AVON, SOUTH DAKOTA – October 8, 2002

A regular meeting of the Avon City Council was held on the above date at the Avon Public Library at 7:00 p.m. Roll Call: Mayor Bechtold, Aldermen Tjeerdsma, Kuhlman, Reister Tolsma, Cameron, and Finance Officer Berndt. Also present were Roger Frey, Orval Elliott, Nelson Lagendyk, Mel Mayer, Lori Kocmich, Mellissa Petrik, Bev Myer, Mike Muller, Ilene Muller, Roland Luke, Allen Kocmich, Jack Brodeen, Greg Henderson, District III, and Jon Winklepleck, Piorier Implement. Absent: Alderman Mensch.

Meeting called to order by Mayor Bechtold at 7:05 p.m.

Motion by Reister and seconded by Kulhman to approve the agenda. All voted "aye". Motion carried.

Motion by Tolsma and seconded by Tjeerdsma to approve the minutes of the September 3, 2002 meeting. All voted "aye". Motion carried.

At this time Mayor Bechtold open the meeting to Public Time. A concern was voiced regarding the fence beside the Senior Citizen Center; Mayor Bechtold will talk to the owner regarding repairs.

The next issue was the horses within the city limits. Mayor Bechtold explained the ordinance read that they could be no closer than 200 feet from a residence, and they are in line with other animals with in the city limits. It was discussed that if the citizens felt they wanted the ordinance strictly enforced that it would effect more than the horse owners.

Bev Myer owner of the horses was in attendance and explained that they have intentions of moving the horses when they find a suitable place. They moved quickly and this was the only solution available at the time.

Seconded by Reister. Roll call vote: Kuhlman, Tolsma, Tjeerdsma, Reister and Cameron all vote "aye". Mensch absent. Motion carried.

The subject of Ambulance rates was discussed, we now must accept assignment from Medicare, which mean we can only collect what Medicare and a clients supplement pays. At present we charge substantially less then surrounding area towns.

We will check on two items of concern and revisit the issue at a later date.

Motion by Tolsma and seconded by Reister to approve the following Equipment rental rates effective immediately. All rates are per hour and with an operator; Pay loader \$100.00,

Patrol \$75.00, Blue Truck \$40.00, Red Truck \$50.00, Tractor \$25.00, Lawn Mower \$40.00, Water Pump \$30.00, Packer \$15.00. No exceptions.

The matter of old vehicles around town was discussed again if you have vehicles we ask that you try to make arrangements to get them removed.

The Avon apartment lawn was brought up as a concern, Berndt will contact them and ask that it be mowed for winter.

We need to collect pipe prices and start working on a bid for the drainage project. We will ask Kocmich to collect the prices for the special meeting.

Motion by Reister and seconded by Kuhlman to set a Special Meeting for October 17<sup>th</sup> at 7:00 p.m. Subjects at the meeting will include the Bid for a pay loader, the prices for pipe, and Ambulance rates.

Another concern brought to the Council attention was the matter of individuals blowing leaves into the street. The Council would like to ask individuals not to do this as it causes other problems. When these leave are washed down the street they plug the manholes and slow water drainage.

Having no other business, a motion was made by Kuhlman seconded by Cameron to adjourn at 9:45 p.m. All voted "aye". Motion carried.
