Meeting called to order by Mayor Bechtold at 7:05 p.m.

Finance Officer Berndt presented Ordinance #283 the Supplemental Appropriation Ordinance to spend the money needed for the pool project. Motion by Kuhlman and seconded by Reister to approve the ordinance. Roll call vote was taken. All voted "aye". Mensch absent. Motion carried. Ordinance #283 appeared in its entirety in February 4, 2004 paper.

At this time the Council reviewed the bid notice for the city pasture. After some discussion motion by Kuhlman and seconded by Reister to let bid of pasture for one (1) year and then to let the pasture sit idle in 2005. All voted "aye". Motion carried.

Motion by Tolsma to introduce the following resolution:

## RESOLUTION

WHEREAS, it is necessary to hold an annual election for the election of certain municipal officers, it is therefore

RESOLVED THAT WHEREAS, pursuant to the law of the State of South Dakota, an annual election for the election of Municipal Officers is required to be held on the second Tuesday of April each year, the City Finance Officer be, and she is hereby authorized and directed and is required to give notice of such election by publication being not less than ten days prior to such election, and the officers to be voted for thereat.

That the polling place for all Wards shall be at the Avon Fire Hall of Avon, South Dakota in accordance with Ordinance of Record, and the polls at such election shall be open continuously form 7:00 a.m. to 7:00 p.m. of said day, that the City Finance Officer be authorized and directed to prepare office ballots for said election.

The following persons by and they are hereby appointed Municipal Election Clerks: Myra Klock, Reta Ridgway, and Shirley Yonkers.

Seconded by Reister to accept the above printed resolution as read. All voted "aye". Motion carried.

The council reviewed the notice for gravel and radius. Motion by Reister and seconded by Tjeerdsma to advertise for gravel and radius work to open bids at the March 1, 2004 meeting. All voted "aye". Motion carried.

The Mayor shared information with the council regarding the petition to place the repeal of sales tax on food on the November ballot. The Municipal League is asking that city leaders do their part to educate people on what would be lost if this measure was passed by the voters.

At this time the Tjeerdsma moved that the City Council adopt the following Resolution Opposing The Repeal of Sales Tax on Food

WHEREAS, The City of Avon annually receives an estimated \$15,603.96 in revenue for the sales on food; and

WHEREAS, there is no revenue source being proposed to replace the lost revenue if the sales tax on food is repealed; and

WHEREAS, the repeal of the sales tax on food could mean significant cuts in service provided by the City, and

WHEREAS, cities are extremely limited in their ability to increase any alternative tax to replace lost revenue, and

WHEREAS, the proposed ballot initiative will provide a tax break for all, without considering whether or not such a tax break is needed;

NOW THEREFORE, it is hereby resolved that the City of Avon opposes the Repeal of sales tax of food;

AND IT FURTHER RESOLVED that the City of Avon urges the circulators of the petition to withdraw their drive to place the repeal of the sales tax on food on the ballot.
