The street plan was discussed. Mayor Frey suggested that the City needs to be more aggressive on the street project. Mayor Frey suggested that the City consider doing 8 to 10 blocks this year, 5 blocks in 1999, and no streets in 2000 do to the Centennial.

A brief discuss was held on the new development. The City is in the process of getting bids for parts for the project.

Motion by Einrem and seconded by VanGerpen that a proposed 8 to 10 blocks be put in the street plan for 1998. All voted "aye". Motion carried.

Finance Officer Haenfler gives Ordinance #260 entitled "An Ordinance Prohibiting The Operation Of Snowmobiles Within The City Of Avon During Certain Hours and Amending Ordinance No. 190" it's first reading. Motion by Einrem and seconded by Reister to approve the first reading of Ordinance #260 as read. Roll Call: Reister, VanGerpen, Einrem, and Knoll all voted "aye". None voted "naye". Absent Alderman Oster and Deurmier.

Motion by Einrem and seconded by VanGerpen to advertise for pasture rent bids to be opened at the March City Council meeting. All voted "aye". Motion carried.

Motion by Reister and seconded by Knoll to advertise for rental of concession stands at the parks and pool, and advertise for the summer recreation program. Bids to be opened at the March meeting and summer recreation program recommendations from the park board will be presented to the Council at the April meeting. All voted "aye". Motion carried.

Motion by VanGerpen and seconded by Einrem to set April 14, 1998 as election day for the municipal election and to hold the election in conjunction with the Avon School District election. All voted "aye". Motion carried.

Recycling was tabled until the March meeting.

Motion by Knoll and seconded by Einrem to send Lloyd Hieb and Duane Stimpson to be certified to spray chemicals at no cost to the City. All voted "aye". Motion carried.
