## UNOFFICIAL MINUTES FOR AVON, SOUTH DAKOTA – FEBRUARY 3, 2003

A regular meeting of the Avon City Council was held on the above date at the Avon City Building at 7:00 p.m. Roll Call: Mayor Bechtold, and Aldermen: Tjeerdsma, Tolsma, Kuhlman, Mensch, Cameron, Reister and Finance Officer Berndt. Also present were Roger Frey, Beth Dykstra, Leland and Kelly Tjeerdsma, Vicki Roth, Bob Macy, Jack Brodeen, Brenda Fennema, Dick Pier, and Allen Kocmich.

Meeting called to order by Mayor Bechtold at 7:05 p.m.

Motion by Tolsma and seconded by Reister approve the agenda. All voted "aye". Motion carried.

Motion by Reister and seconded by Kuhlman to approve the minutes of the January 6, 2003 meeting. All voted "aye". Motion carried.

Carol Deurmier and Dave Brandt arrived at 7:20 p.m.

At this time the mayor opened the floor to public concerns. None were shared at this time.

Then prior to opening the pool comments we did review the facts, which the Council and committee had heard during the meeting on the 27<sup>th</sup> of January, regarding the pool company's feelings regarding a start date, and the update on the grant. At this time all the papers have been signed. Mayor Bechtold then opened the floor to comments.

There were questions regarding MCR involvement thus far. Bechtold explained that they are the only company in the area and we are in need of some type of expertise. Kuhlman shared that they also are one company, which the state will accept plans from much like an engineer's plans.

The other big question was in regard to a start date. There were two definite lines of thought. 1) Start now regardless of a loss of part or all of the season. Finance Officer Berndt commented that if the lifeguards could not be given some idea of how much time they could expect she doubted that she would have some of them return. 2) Hold off until August and then work till snow and begin in the Spring as soon as possible. While there is still a risk of losing part of a season, hoping that it would not be as much of a threat or as long of a time.

Tim Weidenbach arrived at 7:40 p.m.

At this time no decision was made.

Discussion ended at 7:50 p.m. the following individuals left Beth Dykstra, Leland and Kelly Tjeerdsma, Vicki Roth, Brenda Fennema, Dick Pier, Carol Duermier and Dave Brandt.

Mayor Bechtold presented the police report on behalf of Roland Luke. The department did receive funding on a 90/10 grant for a light bar and we will then be responsible to install the unit.

At this time Mayor Bechtold recognized Tim Weidenbach. We was the bidder on the old library building. It was explained that we set a value of 1,000.00 so at this time it is our understanding that we must receive a bid of 900.00. Tim at this time would not want to give that much considering the work he felt he would need to do. The Council asked Finance Officer Berndt to check on options they had and they would get back to him. Tim left at 8:05 p.m.

In order to get grants for these types of projects we would need to almost double the current water and sewer rates. Then we could apply for assistance with these types of projects. The city will do some checking but at this time the city could not accepte bids. Bids will be returned to the bidders unopened.

Motion by Tolsma and seconded by Cameron to have Finance Officer Berndt let the bid for asphalt, bids will be opened at the March meeting. All voted "aye". Motion carried.
