President Kuhlman introduced Jon Clem, of District III to the council and others present. Mr. Clem was asked to come by several Council members to help with planning on projects. He spoke of the steps the city would need to take in order to get on the State

Water Plan, which is the only way to qualify for state grant money. He will get back to Finance Officer Berndt with the requirements. He ask the council some questions so he would have a better idea of what the furture plans include.

He also spoke briefly on the possible grants available for a joint library, but had only a few details, since he still had to meet with Mr. Oster regarding the plan.

He left after his presentation at 7:45 p.m.

Next Street and Water Commissioner Kocmich addressed the council as to his feelings about the payloader they had looked at after the meeting on Jan. 22. He shared that he felt the two machines that should be considered were the 97 Hyundai 750 – Poirier – for \$59,500.00 and the 2000 Hyundai 740 – Bell – for \$55,000.00. He spoke about both machines, giving the council a good idea of what he felt the machines strength and weaknesses were.

Next the Poirier representatives once again addressed the council on there feeling regarding their machine.

Motion by Tjeerdsma and seconded by Tolsma to set a Special Meeting for Thursday Feb. 7, at 5:30 p.m. in order to make a final vote on the payloader. All voted "aye". Motion carried.

The two Poirier Representatives and Roger Frey left at 8:10 p.m.

The Library Board presented their ideas on what they felt needed to be done with the BJ's Building in order to move the library, they were given the original idea presented by Alderman Tjeerdsma last year. They discussed that either plan would work for them. Alderman Kuhlman shared that he felt if the move were made that the office should be moved as well. There was no objection to this by the Library Board.

Terry Schultz arrived at 8:20 p.m.

Alderman Kuhlman explained that he felt that the council should attend the school board meeting next week and at least hear their ideas. The Library Board also expressed an interest in attending the board meeting.

The Library Board left at 8:30 p.m.

Police Chief Luke presented the police report for the past two months. He then discussed the possibility of the police department getting a cell phone for the car.

Motion by Tjeerdsma and seconded by Mensch to obtain a cell phone, for around a cost of \$25.00 per month, to be taken from police supplies. All voted "aye". Motion carried.

Luke left at 8:45 p.m.

Motion by Tolsma second by Tjeerdsma to set the city municipal election for 9<sup>th</sup> day of April 2002. All voted "aye". Motion carried.

Finance Officer Berndt present some income and cost statistics to the council regarding the ball teams and pool. The council reviewed the number asked some question and then made some suggestion that Berndt will present to the Park Board when they meet later this month.

Mensch left at 9:15 p.m.

Motion by Tolsma and seconded by Tjeerdsma, to allow Kocmich to purchase more rock for use at the lagoon, and to order tires for the mower. All voted "aye".

Motion carried

Motion by Cameron seconded by Tolsma to adjourn at 9:35 p.m. All voted "aye".
