That the polling place for all Wards shall be at the Avon Fire Hall of Avon, South Dakota in accordance with Ordinance of Record, and the polls at such election shall be open continuously from 8:00 a.m. to 7:00 p.m. of said day, that the City Finance Officer be authorized and directed to prepare office ballots for said election.

Finance Officer Haenfler presented the Annual Statement of Financial Affairs to the Council. Motion by Reister and seconded by Deurmier to accept said report. Roll Call: VanGerpen, Einrem, Reister and Deurmier all voted "aye". None voted "naye". Motion carried. Absent Alderman Oster.

The Council discussed investing some of the City money into short term CD's. Finance Officer Haenfler will check into this matter.

Motion by Reister and seconded by VanGerpen to set the dates for the Board of Equalization meetings for March 15 at 7:30 p.m. and March 16 at 6:00 p.m. Meeting to be held at the City Library. All voted "aye". Motion carried.

Alderman VanGerpen informed the Council about a hole by Steckler's alley and water doesn't drain properly. Mayor VanGerpen will check into the matter.

Alderman Einrem informed the Council that Gerald Hayward has a gentlemen's agreement with the City from 10 years ago in which the City will provide gravel for driveway to field so City can drain water through that area. Mayor VanGerpen will work with Kocmich to take care of this matter.

A discussion on a different truck was held. There are two trucks in Huron on hold at Surplus Property. The Council agreed to have Alderman Einrem go to Huron and check the trucks out. If needed a special meeting will be held to decided whether to purchase one of these trucks.

Alderman Oster arrived at 8:20 p.m.

Discussion was held on the streets. Work needs to be started on the streets ASAP. Gravel needs to be added to the streets tore up. Alderman Oster suggested that the City mat all the blocks that are tore up this year, so that they are complete for the Centennial, do not tear up any streets next year, and either do a supplemental budget to cover cost above this year's budget or work out a deferred payment with Commercial Asphalt. Finance Officer Haenfler will contact Commercial Asphalt to work out a plan.

Mike Jonkers would like more gravel on Evergreen Street so water will drain. It was suggested that gravel be put level with the curb and when the street needs to be prepared for matting roll gravel back and use for the crown of the road. The Council agreed this would be fine.

Finance Officer Haenfler informed the Council that Duane Stimpson will not be working for the City any longer and there is funds available to hire a Green Thumb person and someone is interested in working for the City under Green Thumb.

Motion by Oster and seconded by Reister to approve hiring of a Green Thumb person. All voted "aye". Motion carried.

Finance Officer Haenfler talked to Bob Hille from H & H Contracting. There are some things that still need to be completed on the water tower. Hille will come to a Council meeting and discuss them with the Council.

There being no further business to come before the Council at this time, a motion was made by Einrem and seconded by VanGerpen to adjourn at 8:45 p.m. All voted "aye". Motion carried.
