At this time Mayor Frey opened the discussion regarding the library move. Library board member, Joanne Bryan had met with Alderman Tjeerdsma and they had come up with some compromises concerning the move. Alderman Kuhlman suggested waiting until the school had a final plan developed before going ahead with moving the library. The Library Board and some Council members felt that was too far down the road and would like to go ahead and make the move now.

Also the city had received a letter from District III regarding funds for Rural Development Community Facilities Program, which was given to both the Council and Library Board. The city could perhaps receive a 35% grant through the program.

There was discussion on whether or not the finance office should also be moved. Alderman Cameron noted that if both the library and finance office were not moved he didn't think he could support the move.

Roland Luke arrived at 7:50 p.m.

Motion by Tjeerdsma and seconded by Tolsma to move the finance office and Library to the BJ's building. The renovations will include a handicapped unisex restroom. The city has \$10,000.00 budgeted for the project. A grant will be applied for (as of 3/12/02 the grant process was halted, due to engineering requirements and also time constraints). Alderman Tjeerdsma will be the Council representative working with the Library Board on the project. Aldermen Tjeerdsma, Tolsma and Cameron voted "aye". Alderman Kuhlman voted "nay". Motion carried.

The Library Board members, JoEllen Wormsbecher and Charles Bryan left at 8:05 p.m.

Finance Officer Berndt presented the council with the 2001 Annual Report. This will be sent to the Legislative Audit as well as published in The Avon Clarion within the

next month. Motion by Kuhlman and seconded by Tolsma to accept the 2001 Annual report. All voted "aye". Motion carried.

Motion by Kuhlman and seconded by Tjeerdsma to set the week of April 22-26, 2002 as the Annual City Wide Clean-up Week. All voted "aye". Motion carried.

Alderman Mensch arrived at 8:25 p.m.

Motion by Cameron and seconded by Tolsma to run advertisement for Concession Stand bids to be approved at the April meeting. All voted "aye". Motion carried.

Motion by Kuhlman and seconded by Tolsma to set Board of Equalization Meeting for March 18, 2002, at 5:00 p.m. All voted "aye".

Motion by Tolsma to adopt the following Resolution:

## RESOLUTION

WHEREAS, it is necessary to hold an annual election for the election of certain municipal officers, it is therefore

RESOLVED THAT WHEREAS, pursuant to the law of the State of South Dakota, an annual election for the election of Municipal Officers is required to be held on the second Tuesday of April (April 9, 2002) each year, the City Finance Officer be, and is hereby authorized and directed and is required to give notice of such election by publication being not less than ten days prior to such election, and the officers to be voted for thereat.

That the polling place for all Wards shall be at the Avon Fire Hall of Avon, South Dakota in accordance with Ordinance of Record, and the polls at such election shall be open continuously from 8:00 a.m. to 7:00 p.m. of said day, that the City Finance Officer be authorized and directed to prepare office ballots for said election.

The following persons by and they are hereby appointed Municipal Election Clerks: Myra Klock, Rita Ridgway and Shirley Yonkers.

Seconded by Cameron. Roll Call vote: Kuhlman, Tjeerdsma, Cameron, Tolsma, and Mensch. All voted "aye". Motion carried.

The Council directed Finance Officer Berndt to set up a time that they could meet with City Attorney Alberts in order to get their questions answered regarding the budget concerns for the purchase of a payloader.

Motion by Tolsma and seconded by Kuhlman to direct Finance Officer Berndt to have the copy machine repaired. All voted "aye". Motion carried.
