Motion carried.

Motion by Kuhlman and seconded by Tjeerdsma to set the times on the ordinance from 7:00 a.m. until 12:00 a.m. midnight. Tolsma, Den Ouden, Reister, Tjeerdsma and Kuhlman all voted "aye". Dertien voted "naye". Motion carried.


