NOW THEREFORE, BE IT RESOLVED, that in accordance with SDCL 35-1-5.3, as amended, authorization is hereby given to the Bar Nothing Band for the sue of the Avon American Legion Hall and to mix or blend and consume alcoholic beverages upon and within the aforesaid premises on the 29th day of July, 1995 between the hours of 9:00 P.M. and 1:00 A.M.
