The meeting was called to order by Mayor Petrik at 7:06 P.M.

All stood and said the pledge to the flag.

Motion by Alderman Berndt and seconded by Alderman Tjeerdsma to approve the agenda. Motion carried.

Motion by Alderman Petrik and seconded by Alderman Dodge to approve the minutes of the July meeting. Motion carried.

FO Simmons stated that the pool will be closing on Sunday, August 9th. Al added that 2 lifeguards, Gracie Small and Madi Mudder are supposed to come in and clean up the pool area on Monday, August 10th.

Public Time -

Clint Powell began talking about the chip seal project. He is planning to be at the SCWDD meeting tomorrow to present the grant request for Avon. The GIS project should be starting this week. The TAP (DOT) meeting is tomorrow.

Old Business -

Dean will be present off and on at the street dance this Saturday, August 8th at Pour Corner. Al talked to the code enforcer about the Nellis property. Eric Nellis is willing to sell and has agreed that he will work with him, not the city because of past bad feelings. Motion by Alderman Berndt and seconded by Alderman Dodge to approve the sale handling by the code enforcer. Motion carried.

New Business -

Motion by Alderman Berndt and seconded by Alderman Dodge to allow the mayor to sign all documents related to the pool/rec grant through District III. Motion carried.

Motion by Alderman Dodge and seconded by Alderman Petrik to approve the annual 3% raise in water, sewer, and garbage rates beginning in September. Motion carried.

Motion by Alderman Tjeerdsma and seconded by Alderman Dodge to approve the propane contract submitted by Best Propane in Wagner. Motion carried.

Matt Eggers had requested that Bailey Laage get reimbursed for helping him out with the Teeners this year. After some discussion, the council decided no because it is not fair to those who helped Travis, Jeff, and Janelle this year.

Ordinance 344, an ordinance updating building permit requirements, was introduced. The first reading was made. The only change is that a building permit must be bought no matter what the project is. Formerly the ordinance stated that the project had to be \$ 500 and over for a building permit to be necessary. Now, no matter the cost, a building permit is required.

Motion by Alderman Berndt and seconded by Alderman Dodge to leave the dog ordinance as is. Motion carried.

Because of a recent drowning, it has been suggested that the city and the fire department conduct a class or classes to help adults and children cope with the issue. There was a consensus that there is other help out there for those who need it.

A dental/vision insurance plan had been brought up several months ago. The council looked over the policy and approved its presentation to the city employees. It would be fully funded by the employees.

The council decided that there does not need to be a "No Parking" sign out in front of the city office. It is a red curb and people are supposed to know better. We also have a business owner that does it so the council said that if it is wrong, it is wrong for all.

Mayor Mike Petrik was elected as delegate to the Missouri Valley and Alderman Randy Berndt was elected as the alternate.

Bradley Voigt and Barb Jonkers will be on the Park Board.

Motion by Alderman Berndt and seconded by Alderman Dodge to declare the old street sweeper surplus. Motion by Alderman Tjeerdsma and seconded by Alderman Berndt to declare the John Deere Sickle Mower surplus. Motion carried.
